**TERMS AND CONDITIONS** 

Effective: January 15, 2025

1. Introduction

1.1. These Terms and Conditions (hereinafter referred to as "T&Cs") set forth the

conditions applicable to the "Budapest Bitcoin Conference 2025" event (hereinafter

referred to as the "Event"), organised by Road 21 Konferenciaszervező Kft. (hereinafter

referred to as the "Organizer").

1.2. The purpose of these T&Cs is to regulate the legal relationship between

Participants and the Organizer, including ticket purchases, participation in the Event,

and other related rights and obligations.

1.3. By accepting these T&Cs, a contract is established between the Participant and

the Organizer, the detailed rules of which are set out in this document.

2. Event Details

2.1. Name: Budapest Bitcoin Conference.

2.2. Venue: Bálna Budapest (1093 Budapest, Fővám tér 11-12.).

2.3. Date: August 8-9, 2025.

## 3. Duration of the Agreement

3.1. The agreement between the Participant and the Organizer is established on the ticket purchase date and terminates automatically following the Event's conclusion unless obligations arising from the agreement remain in effect (e.g., refund requests, complaint handling).

## 4. Conditions of Participation

- 4.1. A valid ticket is required to attend the Event. Tickets can only be purchased through the official platforms designated by the Organizer.
- 4.2. Participants must comply with the venue's house rules, safety regulations, and any additional rules set forth by the Organizer.
- 4.3. The Organizer reserves the right to exclude any Participant from the Event if their behaviour endangers the safety of others or disrupts the order of the Event.

## 5. Payment Terms

### 5.1. Payment Methods:

Tickets can be purchased using the following payment methods:

- Stripe Credit Card Payment: Through the official ticket purchasing platform.
- Bitcoin (BTC): Participants can also purchase tickets using Bitcoin via the payment system powered by BTCPayServer.

### 5.2. Invoicing:

The Organizer will issue an invoice for the payment, which will be sent to the email address provided at the time of purchase. In the case of Bitcoin payments, the

invoice will reflect the transaction's value in Hungarian Forints (HUF) based on the applicable exchange rate.

## 6. Right of Withdrawal and Termination

### 6.1. Withdrawal for Consumers:

Consumers who purchase tickets are entitled to withdraw from the purchase without providing a reason within 14 days of the transaction. In the case of Bitcoin payments, the refund will be calculated in Hungarian Forints (HUF) based on the original transaction exchange rate at the withdrawal time.

6.2. The right of withdrawal cannot be exercised if the Event takes place within the 14-day withdrawal period and the consumer explicitly requested the performance of the service.

## 7. Limitation of Liability

- 7.1. The Organizer reserves the right to cancel the advertised Event for any reason, including but not limited to force majeure, economic circumstances, or other factors beyond the Organizer's control. In such cases, the Organizer agrees to refund the price of purchased tickets to the buyers fully; however, the Organizer shall not be liable for any additional compensation or reimbursement of costs.
- 7.2. The Organizer excludes liability for any damage caused by the Participant's fault or events occurring outside the scope of the Event.

# 8. Copyright

8.1. The content of this website qualifies as a copyrighted work under Section 1(1) of Act LXXVI of 1999 on Copyright in Hungary and is fully protected by copyright law. The use of any images, texts, or other materials found on the website without permission and harmful applications that modify the website is prohibited under Section 16(1) of the same act. Materials, images, videos, and texts from this website and database

may only be used with the copyright owner's written consent, along with proper attribution.

- 8.2. The lectures, presentations, and related materials presented at the Event are protected by copyright.
- 8.3. Participants may use the materials exclusively for personal purposes. Redistribution or publication of the materials is only allowed with the prior written consent of the author(s).

### 9. Final Provisions

- 9.1. Hungarian law governs these T&Cs.
- 9.2. The Organizer reserves the right to amend these T&Cs unilaterally. Amendments take effect on the date of publication.
- 9.3. The parties agree to attempt to resolve any disputes amicably. If no agreement is reached, disputes will be submitted to the competent Hungarian court.
